## Company overview

- Mondiale VGL is Oceania's leading sea freight forwarder and a significant player in the global supply chain solutions sector.
- Mondiale VGL employs over 1500 staff across 56 offices in New Zealand, Australia, Asia, Europe, and the USA, and is supported by 1000 agency offices worldwide.
- The firm was established through the merger of two of the largest freight companies in Australia and New Zealand: Mondiale Freight Services Ltd and VISA Global Logistics Pty Ltd (VGL), in 2021.
- The merger placed Mondiale VGL in the world's top 30 freight forwarding companies.
- Mondiale Freight Services was established in Auckland in 1989. VISA Global Logistics was established in Sydney in 1982.
- Mondiale VGL acquired South Australian-based customs and logistics business, Customs Agency Services (CAS), in December 2021.
- Today, Mondiale VGL continues to be owned by founding shareholders from both businesses alongside Direct Capital and ACC.

- Mondiale VGL offers a fully integrated, door-to-door service, supported by proprietary technology, comprised of:
  - Global freight forwarding
  - Customs clearance
  - Third- and fourth-party logistics warehousing
  - Transport and distribution
  - Supply chain logistics strategy and consultancy
  - Container fumigation and heat treatment.
- Using 700 pieces of transport equipment, Mondiale VGL moves approximately 485,000 TEUs (20-foot container) of sea freight and 21,000,000 kilograms of air freight per annum.
