Terms and Conditions of Credit Application

1. This is an application only for credit and Mondiale VGL Limited reserves the right to accept or reject this application, or to accept it only in part, or to accept it subject to such conditions as it may, in its sole discretion, consider appropriate. No credit will be extended to the applicant until Mondiale VGL has notified the applicant of acceptance and the terms of such acceptance.
2. Mondiale VGL may, in considering this application and at any time after the application may have been granted, make such credit checks and other inquiries about the applicant as it deems necessary. The applicant hereby irrevocably authorizes Mondiale VGL from time to time to seek and obtain information about the applicant's financial standing and credit worthiness from any person, including any security holder or creditor, whether past or present. In signing this application, the applicant authorizes such persons to provide the requested information and agrees that this authorization is sufficient for the purposes of the Privacy Act 1993.
3. Notwithstanding the granting of credit, Mondiale VGL reserves the right at any time and for any goods, to require payment in full in cash or by bank cheque before goods are released.
4. Under no circumstances will credit be extended for disbursements that are or will be payable in cash to any third party. Such disbursements may include Customs goods and services tax, Customs duty and freight which is payable on "freight collect" consignments. All sums for disbursements must be paid to Mondiale VGL in full, in cash or by bank cheque, before goods are released.
5. Mondiale VGL may, at any time and without giving reasons, cancel any credit terms and, if it does so, may require any sums then owed by the applicant to be paid in full forthwith.
6. Payment of sums due pursuant to any credit arrangement must be made strictly in accordance with the terms of that arrangement. If full payment is not made by the due date then, without prejudice to any other remedies available to Mondiale VGL, interest on monies overdue may be charged on a daily basis and be calculated by adding 5% per annum to the overdraft rate payable by Mondiale VGL to its bankers at the time of and during such default and interest shall continue to accrue both before and after judgement.
